Rules for the Admission of Foreign Citizens to Specialist Programs at Kuban State Medical University

For a foreign citizen (who does not hold Russian citizenship) to be admitted to a specialist program on a paid basis, the applicant must complete an electronic application on the KubSMU website from *June 20 to July 15, 2025* (<https://abitur-for.ksma.ru/>) to participate in the competition for admission to the specialist program and upload **copies of the following documents** when filling out the application:

- Passport of the foreign citizen (all pages);
- Translation of the passport into Russian;
- Original educational document of state standard (certificate, diploma, transcript);
- Notarized translation of the educational document into Russian;
- Legalization of the educational document (except in cases provided by law);
- Confirmation from the Federal Service for Supervision in Education and Science (Rosobrnadzor) regarding the equivalence of the educational document (except in cases provided by law);
- Certificate of completion from a preparatory faculty (except for applicants from neighboring countries);
- Information about the availability of a medical examination certificate, certificates from a narcologist, psychiatrist, and chest X-ray results, certificate of HIV status, vaccination certificate (vaccinations according to age). The medical examination can be carried out in Krasnodar, and it is recommended to bring the vaccination certificate with you.

You may also submit the specified documents in person to the international department.

Entrance exams are scheduled to be conducted in the form of an oral interview, in person, in July on three subjects: **chemistry, biology, and Russian language**, *from July 22 to July 24, 2025*.

Upon successful completion of the competition, the candidate will be enrolled in the 1st year as a student in the specialist program with instruction in Russian. An important condition is the presence of specialized subjects (chemistry and biology) in the high school certificate. Afterward, students undergo an additional medical commission and then attend classes, and are accommodated in the dormitory (if necessary).

After this, the university extends the existing study visa (**the visa must be valid until at least August 31, 2025**). If the student is from a visa-free country, the duration of stay will be extended (the current duration of stay must not end earlier than August 31, 2025). In this case, the migration card must indicate the purpose of arrival — STUDY.

The cost of studying in the specialist program in Russian at present is:

- For the Faculty of Medicine: 230,000 rubles/year;
- For the Faculty of Dentistry: 310,000 rubles/year;
- For the Faculty of Pharmacy: 166,000 rubles/year;

The cost of accommodation in a dormitory is approximately 16,000 rubles/year, and the cost of an insurance policy is about 6,000 rubles/year.

Please note that according to the admission rules of KubGMA, the tuition fees for foreign students must be paid within the established deadlines.

We inform you that as of December 29, 2021, Federal Law No. 274 of July 1, 2021, which amends Federal Law No. 115 of July 25, 2002, "On the Legal Status of Foreign Citizens," came into effect. All foreign citizens arriving after December 29, 2021, must undergo medical examination and fingerprinting within 3 months of arrival in the Russian Federation. The cost is approximately 10,000 rubles.

You may also apply based on the results of the Unified State Exam (if you have them).

Payment for tuition is made within the deadlines specified in the contract.

Payment for accommodation in the dormitory is made for the entire year before moving into the dormitory.
